

TERMS AND CONDITIONS

Pep Drive Competition

Vodacom Vodacom (Pty) Ltd ("Vodacom") is running the Pep drive competition where six (6) Lucky customers who have entered the competition through any of the participating Pep stores in the Nelson Mandela Metropolitan Municipality stand a chance to win a Shoprite/Checkers Voucher valued at R750 (Seven-Hundred and Fifty Rand only) by purchasing a smartphone device (Cash or Fone yam sale) then load airtime of at least R29 (Twenty-nine Rand) or more, then dial *120*878# from the new Vodacom number (that came out with the device) and submit information as requested by the prompts.

All participants during the term of the Competition agree to be bound by the following Terms and Conditions:

Duration

1. The competition to customers that purchase a Vodacom smartphone device at any of the participating Pep stores (Pep Clothing, Pep Home and Pep Cell), then recharge with Vodacom airtime of R29 or More on their new device (with the new Vodacom sim-card) between 01 August 2026 to 31 October 2026
2. The duration of the Competition may be extended or curtailed at the discretion of Vodacom.

Prizes

3. Six (6) Lucky Entrants stand a chance to win a Shoprite/checker Voucher valued at R750 (Seven-Hundred and Fifty Rand only). In total, there will be Six (6) winners with a total prize value of R4 500.00 (Four thousand five hundred Rand) in shoprite/checkers Vouchers,
4. There will be 2 winners a month.
5. After purchase of smartphone device, recharge of R29 – R54 equates to 1 entry, recharge of R55 – R99 equates to 2 entries and recharge of R100 or more equates to 3 entries into the competition.
6. Non-transferability: The Voucher prize is non-transferable and may not be exchanged for any other prize or service.
7. Payment Timeline: The Voucher prize will be awarded within 7 working days after winner verification.
8. Tax Implications: Vodacom is not responsible for any tax implications arising from the prize. Winners are advised to seek independent financial advice.
9. Unclaimed Prizes: If a winner does not claim the prize within the stipulated timeframe, the prize will be forfeited.
10. No Additional Costs Covered: Vodacom will not cover any additional costs incurred by the winner in terms of accessing or using the prize.
11. Prize Cap: Each winner may only win once during the campaign period. Subsequent entries will be disqualified.

Eligibility

12. Only entries received during the Competition period as stipulated in clause 1 above will qualify as potential winners.
13. The Competition is only open to natural persons that are eligible to purchase a device from the participating pep stores Entries received from business accounts held by legal persons (amongst other Corporates and SMEs, etc.) are excluded from participating and winning in the Competition.
14. Only entrants who have bought a Vodacom Smart device from the participating stores and entered the competition using their new Vodacom SIM cards that have been RICA registered are eligible to win the Competition. Each owner of a SIM card is responsible for complying with South African law by RICA registering their SIM cards.
15. Employees, directors, and agents of Vodacom and all participating stores, their immediate families, life partners, business partners, and associates, and any person directly involved with the sponsoring, devising, production, management or marketing of this Competition are not eligible to participate in this Competition.
16. Participants must reside in South Africa and be in possession of a valid South African identity document or permanent residence permit or temporary residence permit valid for a period exceeding 3 (three) months for the Republic of South Africa and valid at the End Date.
17. In the event that the user of the mobile phone (i.e. the participant in the Competition) is not the person that is responsible for payment of the participating mobile phone account/ charges, then the prize will be awarded to the person that is responsible for payment of the participating mobile phone account/ charges.

Valid Entry

18. In order to stand a chance of winning in the Competition, qualifying entrants must –
 - 18.1. Participants must reside in South Africa and be in possession of a valid South African identity document or permanent residence permit or temporary residence permit valid for a period exceeding 3 (three) months for the Republic of South Africa and valid at the End Date)
 - 18.2. Purchase a smartphone (Cash or Fone yam sale) then load airtime of at least R29 (Twenty-nine Rand) or more on the new simcard inside the Smart phone bought between 01 August 2026 and 31 October 2026
 - 18.3. Enter the completion by Dialling *120*878# and follow the prompts (R0.20 per 20seconds)
19. Participants are allowed to enter once
20. There are no additional charges for participating in the Competition apart from the standard costs of USSD entry as per Clause 18.3 above. Standard airtime/data/SMS costs apply as per the user's Service Provider and existing price plan.

21. Vodacom shall not be liable for any costs incurred by the winners for entering the Competition or in claiming any prizes, where applicable.
22. Voice reception/data transfer speeds are not guaranteed and are dependent on network availability and utilisation.

Prize draw

23. The competition participants who have entered the competition will go into a Randomizer draw, where 2 winners will be selected every month during the time frame of the competition as per clause 1.

Winner Validation

24. All the information provided or related to this Competition shall be managed, captured and approved by Vodacom.
25. Vodacom will share personal details of the respective winners, such as name and contact number with the Vodacom PE headquarters Sales department, who will notify the respective winners that they have won in the Competition, and you hereby agree to such disclosure as is necessary to effect prize fulfilment.
26. Vodacom will use reasonable efforts to contact the winners via telephone on the contact details provided by the participants to participate in the Competition.
27. Vodacom shall attempt to contact the winners for a period of 2 (two) normal working weekdays after their names have been drawn and verified as winners. The winners will be contacted during normal working hours, between 8 (eight) in the morning and 5 (five) in the afternoon.
28. Should a participant not be available on the contact details provided during the timeframe stipulated above or reject, forfeit, or decline acceptance of the prize, that person's right to the prize will be deemed to have been waived, and the prize will be forfeited. Vodacom reserves the right to then award the prize to the next randomly drawn participant.
29. The claim for any prize will be subject to security and validation, and Vodacom reserves the right to withhold any prize until it is satisfied that the claim by a particular winner is valid. The selected winners must be able to identify themselves, in a manner determined by Vodacom, as the qualifying entrants to the Competition and have to comply with the required validation procedure, determined by Vodacom, in order to claim any prizes, failing which such a winner will forfeit the prize and the prize will be awarded to the next selected qualifying entrant.
30. Notwithstanding the fact that the prizes vest in the winners immediately upon the determination of the results, in the event that the required documentation from a particular winner has not been received at the agreed cut-off date communicated to the winner, or no effort is made on the part of any of the winners to make special arrangements to meet the deadline set by Vodacom, such prize will be forfeited. Vodacom then reserves the right to award the prize to the finalist that is next in line.
31. The winners' names and locations will be share with the participating a store subsequent to notification of the winners.

32. Vodacom shall request the winners' consent in writing to their image and/or likeness being used and published by Vodacom in connection with the Competition for a period of 12 (twelve) months after they have been announced as winners. The winners may decline the use of their image and/or likeness by Vodacom.

Prize Delivery

33. All prizes will be effected by means of a hand delivery to the winners at the store of purchase
34. No prize is transferable or exchangeable.
35. If a winner cannot accept a prize for any reason whatsoever, the prize will be awarded to the next selected entrant.
36. All risks and ownership of the prizes shall pass to the winners on transfer/delivery thereof and hence all of Vodacom's obligations in regard to the Competition as well as in regard to the prizes shall terminate.

Personal information

37. User data collected via the Competition will not be used for any purpose other than for the execution of the Competition.
38. User data collected via entry for this Competition will be stored for as long as it is legally required to and in accordance with Vodacom's Privacy Policy,

General

41. In the event of a dispute in regard to any aspect of the Competition and/or the Terms and Conditions, Vodacom's decision will be final, and binding and no correspondence will be entered into.

Vodacom is entitled in its entire discretion to reject any participant for any reason and will not be obliged to notify participants that they are rejected.
